## 4. FIRST AID MEASURES

If poisoning occurs, contact a doctor or Poisons Information Centre (Phone Australia 131 126, New Zealand 0800 764 766).

### 5. FIRE FIGHTING MEASURES

### 6. ACCIDENTAL RELEASE MEASURES

#### SMALL SPILLS

Work up wind or increase ventilation. Contain - prevent run off into drains and waterways. Use absorbent (soil, sand or other inert material). Collect and seal in properly labelled containers or drums for disposal. If contamination of crops, sewers or waterways has occurred advise local emergency services.

TWA - The time-weighted average airborne concentration over an eight-hour working day, for a five-day working week over an entire working life.
