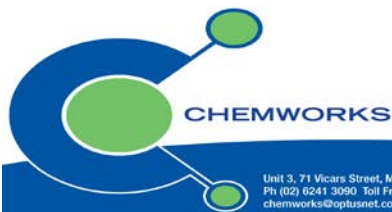
HEALTH EFFECTS FROM EXPOSURE:
